Commercial Banks Total Assets





- Total Assets increased by 1.2% during December 2023 to reach QR1.969 trillion
- Total Assets rise in December 2023 was mainly due to a gain by 1.0% in Domestic Assets
- Total Assets increased by 3.4% in 2023, compared to a growth of 4.2% in 2022. Assets grew by an average 6.8% over the past five years (2019-2023)
- Liquid Assets to Total Assets was at 31.6% in December 2023, compared to 31.4% in November 2023

Commercial Banks Credit Facilities





- Loans went up 1.1% during December 2023 to reach QR1,287.9bn
- Loans gain in December 2023 were mainly due to a rise by 2.6% in the Public Sector and by 0.7% in the Private Sector
- Loans increased by 2.5% in 2023, compared to a growth of 3.3% in 2022. Loans grew by an average 6.5% over the past five years (2019-2023)
- Loan Provisions to Gross Loans was at 4.0% in December 2023, compared to 3.9% in November 2023



Commercial Banks Deposits





- Deposits moved up 0.5% during December 2023 to reach QR986.0bn
- Deposits rise in December 2023 was mainly due to an increase by 4.0% in the Public Sector
- Deposits declined by 1.3% in 2023, compared to a growth of 2.6% in 2022. Deposits grew by an average 4.1% over the past five years (2019-2023)

• Loans to Deposits ratio moved up during the month to 130.6% as at December 2023

• Loans went up by 1.1% in December 2023 to reach QR1,287.9bn, while Deposits moved up 0.5% in December 2023 to reach QR986.0bn



Net Interbank Position



- The Net Interbank Position was at a negative QR297bn as at December 2023
- Due from Banks totaled QR198.5bn as at December 2023
- Due to Banks totaled QR495.9bn as at December 2023
- Due to Banks Abroad reached a high of QR421.4bn in June 2023
