Baladna (BLDN)


- > Net profit increased by 20.7% YoY to QR58mn (+32.4% QoQ) in 1Q2025 primarily due to higher revenue and gain on investment at FVTPL.
- > Revenue was up 5.7% YoY (+15.5% QoQ) to QR331mn in 1Q2025.
- > Gross profit grew by 21.6% YoY to QR87mn (+48.6% QoQ) while the corresponding margin increased by 3.4ppts YoY (+5.9ppts QoQ) to 26.3% in 1Q2025.
- > Operating profit was up 16.5% YoY (+59.3% QoQ) to QR66mn in 1Q2025 while the corresponding margin improved by 1.9ppts YoY (+5.5ppts QoQ) to 20.1% in 1Q2025.
- > For 1Q2025, EPS came at QR0.030 vs. QR0.025 in 1Q2024.
- > As of 28th April 2025, the stock has decreased 0.4% YTD, Outperforming the QSE Index, which was down by 2.5% YTD.
- > The stock is currently trading at a TTM P/E multiple of 17.6x. For now, we maintain our PT of QR1.63/share and Accumulate rating.




Quarterly Sales Trend (QRmn)




Quarterly Earnings Trend (QRmn)
