Mesaieed Petrochemical Holding Co. (MPHC)


- > Net profit decreased by 4.0% YoY to QR186mn (+22.4% QoQ) in 1Q2025 owing to a lower interest income.
- > The share of results from joint ventures increases by 7% YoY to QR166mn (+37.7% QoQ) in 1Q2025.
- > For 1Q2025, EPS came at QR0.015 vs. QR0.015 in 1Q2024.
- > As of 29th April 2025, the stock has Decreased 5.3% YTD, Underperforming the QSE Index, which was down by 2.3% YTD.
- > The stock is currently trading at TTM P/E multiple of 24.9x, higher than its 1Y historical average of 24.1x.




Quarterly Share of Results from Joint Ventures Trend (QRmn)
