Qatar Insurance Company (QATI)


- > Net profit grew by 12.4% YoY to QR195mn (+25.6% QoQ) in 1Q2024 primarily due to an increase in insurance revenue.
- > Insurance revenue increased by 21.4% YoY to QR1,634mn (-1.6% QoQ) in 1Q2024.
- > Insurance service Income came at QR201mn in 1Q2024 vs insurance service income of QR276mn in 1Q2023 and against the insurance income of QR75mn in 4Q2023.
- > Total investment and other income increased by 3.1% YoY to QR221mn (-3.1% QoQ) in 1Q2024.
- > For 1Q2024, EPS came to QR0.045 vs. QR0.038 in 1Q2023.
- > As of 1st May 2024, the stock has decreased 13.5% YTD, underperforming the QSE index, which was down by 10.4% YTD.




Quarterly Insurance Revenue (QRmn)




Quarterly Earnings Trend (QRmn)
