## Qatar Islamic Insurance Group (QISI)


- > Net profit increased by 2.6% YoY to QR44mn 1Q2025 primarily due to lower total expenses and recognized takaful costs.
  - > Recognised Takaful Contributions rose by 13.0% YoY to QR146mn in 1Q2025.
  - > Takaful Gross Margin came at QR50mn in 1Q2025 vs QR-39mn in 1Q2024.
  - > Net Takaful Result came at QR46mn in 1Q2025 vs QR-42mn in 1Q2024.
  - > For 1Q2025, EPS came at QR0.29 vs. QR0.29 in 1Q2024.
- > As of 30<sup>th</sup> April 2025, the stock has decreased 3.3% YTD, Underperforming the QSE Index, which was down by 1.1% YTD.




Quarterly Recognised Takaful Contributions Trend (QRmn)
