Salam International Investment (SIIS)


- > Net Profit increased by 78.6% YoY (+6.1% QoQ) to QR20mn in 1Q2025 primarily due to a higher other income and lower expenses.
- > Revenue decreased by 1.5% YoY (-12.1% QoQ) to QR399mn in 1Q2025.
- > Gross profit increased by 0.4% YoY to QR118mn (-2.2% QoQ) while the corresponding margin came to 29.5% in 1Q2025 (vs. 28.9% in 1Q2024).
- > Operating profit of QR46mn increased by 15.8% YoY (-14.8% QoQ) and margin came to 11.6% in 1Q2025 (vs. 9.8% in 1Q2024).
- > For 1Q2025, EPS came at QR0.018 vs. QR0.01 in 1Q2024.
- > As of 29th April 2025, the stock has increased 0.1% YTD, Outperforming the QSE Index, which was down by 2.3% YTD.
- > The stock is currently trading at TTM P/E multiple of 12.4x. lower than its 3Y historical average of 14.4x




Quarterly Sales Trend (QRmn)
